

Privacy Statement Box2Build Sales BV

This is the Privacy Statement of Box2Build Sales BV, hereinafter referred to as: Box2Build Sales. Box2Build Sales is registered with the Dutch Chamber of Commerce under number 84798041 and is located at Paardenmarkt 11 (2611PA) in Delft. This document explains how Box2Build Sales handles the processing of your personal data. Box2Build Sales takes the greatest possible care when processing your personal data.

Obtaining personal data:

If you use the services of Box2Build Sales, you provide personal data to Box2Build Sales yourself, or personal data is obtained from you in the context of the agreement. Personal data is understood to mean all data relating to an identified or identifiable natural person.

Categories of personal data

Box2Build Sales processes the following categories of personal data:

- Contact and name and address data, including location data, telephone number, e-mail address;
- Company details, including VAT number and Chamber of Commerce number;
- Different delivery address;
- Financial details;
- Other personal data provided by you.

Purpose of the processing

The personal data processed by Box2Build Sales have the purpose of:

- to contact you to inform you about the services you have purchased and their implementation;
- to be able to perform its services;
- to improve its services;
- to be able to make payments;
- to be able to comply with legal obligations;
- to be able to make marketing and communication expressions, including improving the website by analyzing visitor behavior on the website;
- to be able to send newsletters;
- to exchange data with third parties for the performance of the service, insofar as this is necessary.

Basis of processing

The processing of personal data is only possible on the basis of the following principles: (i) legal obligation, (ii) execution of the agreement, (iii) obtained (explicit) consent from the data subjects, and (iv) legitimate interest. Personal data is processed when providing the services of Box2Build Sales. Box2Build Sales only processes data that Box2Build Sales deems necessary for (improving) the service and handles the (personal) data that it has collected about you and your use of the services with care. The basis for processing this data is the agreement that you have entered into with Box2Build Sales. Your personal data can also be processed by visiting the website <https://box2build.com> if you have given permission for this.

Necessity of processing

The processing of your personal data is necessary to be able to carry out the service. The services that Box2Build Sales offers cannot be fully performed without the processing of your personal data. If your explicit permission is required for specific purposes with regard to the personal data, you must give permission for this separately.

Automated decision-making

There is no automated decision-making related to data-processing.

Sales are stored in accordance with the relevant laws and regulations. If a longer retention period is necessary on the basis of legislation or regulations, the personal data will be kept longer in accordance with these requirements. All (obtained) personal data will not be kept longer than strictly necessary.

Processing by third parties

Box2Build Sales only shares personal data with third parties if this is strictly necessary for the execution of an agreement and to comply with relevant laws and regulations. No personal data is sold. Box2Build Sales may have a legal obligation to share personal data with third parties. If personal data is shared with third parties, processing agreements are concluded for this. Possible third parties with whom data is shared are:

- The delivery service(s) engaged for the purpose of executing the agreement. The categories of personal data that are processed are contact and name and address details.
- The Payment Provider, for the purpose of executing an agreement. The categories of personal data that are processed are financial data.
- The Bookkeeper, for the purpose of executing an agreement. The categories of personal data that are processed are contact and name and address data and financial data.
- Software suppliers, for the purpose of executing the agreement. The categories of personal data that are processed are the contact and name and address details.
- Website administrator, for the purpose of executing the agreement. The categories of personal data that are processed are the contact and name and address details.
- Third parties engaged for the performance of the agreement. The categories of personal data that are processed are the contact and name and address details.

Security of Personal Data

Box2Build Sales takes the protection of your personal data seriously and takes into account the state of the art, implementation costs, as well as the nature, scope, context and the processing purposes and the risks that differ in likelihood and seriousness for the rights and freedoms of persons, appropriate technical and organizational measures to ensure a level of security appropriate to the risk.

Cookie statement Box2Build

Sales uses technical and functional cookies to optimize the website. Cookies are small text files that are sent along when you visit a website to make the user experience of visitors more efficient. Box2Build Sales may, by law, store cookies on your device if these cookies are strictly necessary to use the website. Other types of cookies require your permission. Box2Build Sales advises you to accept the cookies in connection with the user-friendliness of the website. Visitors to the website have a check-in option.

The cookies that Box2Build Sales uses are functional cookies: these cookies ensure that the website works properly. These cookies have no consequences for privacy, so that no permission must be requested and granted. With these cookies, for example, your browser settings are stored so that our website can be viewed best, or that the website remains accessible (load balancing), but also cookies that ensure that no other cookies may be placed (no-follow).

Social media

Box2Build Sales uses cookies from third parties to optimize the website. Some cookies are placed by third party services that appear on the website. Browser

settings If you do not want websites to place cookies on your device that you use to view the website, you can adjust your browser settings. Before a cookie is placed, you will receive a warning and you

must give permission for the cookie. Failure to do so may, for example, result in the website not working properly. You can adjust the settings of your browser so that your browser refuses all cookies and cookies from third parties. You can also delete placed cookies. For this you must adjust the settings of your browser via preferences and then you can adjust the privacy settings.

Right of data subjects

As a data subject you have the following rights:

Right of access

As a data subject, you have the right to obtain a definitive answer as to whether or not your personal data is being processed and, if that is the case, to inspect the processing thereof.

Right to rectification

You have the right to obtain rectification and completion of incorrect data;

Right to erasure

A data subject must obtain erasure of personal data concerning him/her without undue delay.

Right to restriction of processing

As a data subject, you have the right to restrict the processing of your personal data. Please contact Box2Build Sales for this.

Right to data portability

A data subject has the right to obtain the personal data concerning him that he has provided to Box2Build Sales in a structured, common, and machine-readable form in order to possibly transfer this personal data to a third party. A data subject can also instruct Box2Build Sales to transfer this data directly to a third party.

Right to object

The data subject has the right to object at any time, on grounds relating to his particular situation, to the processing of personal data concerning him/her, including profiling based on those provisions. Box2Build Sales will cease processing the personal data unless there are compelling legitimate grounds for the processing that outweigh the interests, freedoms and rights of the data subject related to the exercise, institution or defense of legal claims.

Complaint
